OUR CONSTITUTION

PREAMBLE

WE, Members of the Party for Economic and Social Advancement (PESA);

RECOGNIZING the Supremacy of the Almighty God;

ACKNOWLEDGING the supremacy of the Constitution of Kenya;

HAVING founded the PESA party in the year 2024 with a vision to promote economic advancement, social empowerment, inclusivity, equitable national resources distribution and social justice as the core national values towards a united Kenya;

REALIZING the importance of peace, good governance and social- economic development as factors of national cohesion and unity;

INSPIRED by the national quest for progressive democracy and upholding the rule of law,

RECOGNIZING our founding fathers' dreams for a nation free from disease, poverty, illiteracy and hunger;

PROUD of our ethnic, cultural and religious diversity as a nation;

AFFIRMING our belief in the rule of law and abiding by the ideals and values of democracy and good governance through periodic, free and fair elections in conformity with the Constitution of Kenya;

EXERCISING our sovereign and inalienable political rights to determine our governance as PESA;

DO HEREBY ADOPT, ENACT and **GIVE** this constitution to ourselves as Party for Economic and Social Advancement and to our future generations;

ARTICLE 1: NAME OF THE PARTY

- 1.1. The name of the Party shall be Party for Economic and Social Advancement (PESA) Party (hereinafter known and referred to as the Party or PESA Party);
- 1.2. The party shall be a body corporate with a common seal, perpetual succession and may sue and be sued in its corporate name;
